RESOLUTION STUAL GENERAL SHAREHOLDERS MEETING 2020

- Pursuant to the Enterprise Law No. 68/2014/QH13 by the National Assembly of the Socialist Republic of Vietnam on the date 26/11/2014 and entered into force on 01/07/2015;
- Based on the Charter of the organization and the operation of Binh Duong Water Environment Joint Stock Company;
- Based on the content of Annual General Meeting of Shareholders dated 17/03/2020 of Binh Duong Water Environment Joint Stock Company;

The annual shareholders' meeting 2020 of Binh Duong Water - Environment JSC was held at the Company Hall, No. 11 Ngo Van Tri street, Phu Loi ward, Thu Dau Mot city, Binh Duong province. The congress began at 09 hours 00 minutes on 17/03/2020 and ends at 12 hours 00 minutes on the same day;

Attending the meeting there were 659 shareholders (including owned and authorized representative), representing 126,691,339 shares, accounting for 84.46% ratio of charter capital of Binh Duong Water - Environment JSC;

After hearing the reading of the Reports and adopted the Proposals under the Program of Annual General Meeting of Shareholders 2020 of Binh Duong Water - Environment JSC, based on the results of voting at the Congress, Annual General Meeting of Shareholders 2020:

RESOLVES:

- Article 1. Unified content, programs, work regulations and rules of voting at the Congress.
- **Article 2.** Unified content of the Chairman's report on governance and results of operations of the Board in 2019, management plans and direction of the company in 2020.
- **Article 3.** Unified content of the reports of the General Director on the results of production activities of business in 2019, the report of the Chief Accountant of the company on the financial statements audited in 2019, and report on the results of operations of the Control Board in 2019 with the main contents of the following:
 - Total revenue: 2.631 billion VND, reaching 106% of 2019 Shareholder resolutions (2.471 billion VND), increase 17% compared to 2018 (2247 billion);

- Profit after tax for the year was: 465 billion VND;
- Dividends reaching plan: 10% of charter capital

Article 4. Through reports on production and business plan in 2020 of the General Director and the expositions, the General Assembly agreed with the main contents as follows:

• Production and business plan in 2020

- Revenue > = 3,150 billion VND.
- Profit after tax of > = 470 billion VND.
- Commercial water: increase 10% compared with that in 2019.
- Receiving and processing of waste: increase of 10% compared with that in 2019.
- Collection and treatment of wastewater: 38.750 m³/day (4 wastewater branches).
- Client: reaching 35,000 connections.
- Water Loss decreased throughout the company: <= 5.5%/year.
- Dividend expectations: 12% of charter capital.
- Ensure timely implementation of key construction projects.
- Repair, renovation, purchase of equipment to ensure production and business plans.

b. Bonus and welfare : 15% PAT
- Bonus fund : 14% PAT

- Welfare Fund : 1% EAT c. Fund for manager's bonus : 5% EAT

- **Article 7.** Shareholders' General Meeting appointed to the Board of Management, Supervisory Board has the responsibility to monitor and direct the Executive Board to comply with this resolution content.

This resolution was approved by the Annual General Meeting of Shareholders 2020 of Binh Duong Water Environment JSC passed through with 100% of the shares with voting rights attending the meeting and takes effect from 17/03/2020.
